Prior to joining Inchcape Natalia worked for Food City in Moscow, and for more than 10 years at various international FMCG companies.

She started her career at Heinz Russia as the sole in-house legal counsel and supported production, sales, and marketing, as well as leading the integration and due diligence process after the merger of Heinz and a Russian food producer. After Heinz she moved to British American Tobacco, where she focused on advertising law and data and health protection law and represented the company before the control functions and in litigation. She supported the company in the days of Russia becoming a dark market for tobacco.
